# Taking Care of Your Dogs Pads During the Hot Summer Months

Dog's feet and pads are tough, right? Most people are aware that foot pads can be injured by stepping on something sharp, but what about something hot? Dangerously hot pavement and metal surfaces are hard to avoid in the heat of summer. Walking or running on hard pavement is tough on feet, too.

Pavement, metal or tar-coated asphalt get extremely hot in the summer sun. We remember to wear sandals, walk on the grass and not sit down on these surface in the heat of the day (most of the time -- I know that I have been surprised a time or two).

Harder to remember is summer heat and our dog's feet. Unlike the obvious wounds such as lacerations, foot infections (fungal, bacterial), or foreign bodies such as <u>cheat grass</u>), burned pads may not be apparent to the eye, at least initially.

### Signs of burned pads:

- limping or refusing to walk
- licking or chewing at the feet
- pads darker in color
- missing part of pad
- blisters or redness



### Another Way to Injure Pads on Hot Pavement

A colleague and I presented at a wilderness first aid talk for people who love to be in the outdoors with their dogs. One of the audience members shared a story of what had happened to their dog and brought up a good point about foot pad health.

They had been swimming/floating in the river for about an hour and a half. When it was time to go, they walked along the road, but then their Labrador Retriever refused to go on. They figured that he was just exhausted from the swim. Turns out, his foot pads were bleeding and he was in pain. The time in the water has softened his pads up quite a bit and the hot road asphalt severely burned the pads.

# Taking Care of Your Dogs Pads During the Hot Summer Months—continued

### **Burned Pad First Aid**

It is important to keep the foot area cool and clean. As soon as you notice the problem (limping along on the road), flush with cool water or a cool compress if available. Get the dog to a grassy area or if possible, carry him

At first chance, your vet should examine your dog for signs of deeper burns, blisters and possibility of infection. Your vet will determine if antibiotics or pain medication is needed.

Washing the feet with a gentle cleanser and keeping them clean is important. Bandaging can be difficult to do and to maintain (monitor and change often), but licking *must be kept to a minimum*. Some dogs will tolerate a sock to keep the area clean, but caution is advised for dogs that may <u>chew and ingest the sock</u>. Lick deterrents (bitter sprays) may help reduce the damage *caused by* licking.

### **Prevention is Best**

Best advice is to be mindful of hot surfaces -- asphalt and metal (i.e. boat dock, car or truck surfaces) -- and walk your dog on the cool side of the street or in the grass.

Another tip is to lay down a wet towel for your dog to stand on when grassy areas are not available. Good way to keep cool while loading up the car.

This synthetic version of vitamin K has not been specifically approved for long term use, such as in pet food. It has been linked to many serious health issues. If you are not aware of this, it sounds like one of the healthy vitamins, but beware.

The MSDS guide for Menadione Sodium Bisulfite states:

- "Potential Chronic Health Effects:
- CARCINOGENIC EFFECTS: 3 (Not classifiable for humans) by IARC
- MUTAGENIC EFFECTS: Mutagenic for mammalian somatic cells.
- The substance is toxic to kidneys, lungs, liver, mucous membranes
- Repeated or prolonged exposure to the substance can produce target organs damage."

### VHOC Annual Obedience, Rally and Agility Trial

December 4 (Agility Trial and Obed./Rally Match), December 5 and 6, 2015 (Agility/Obed/Rally Trials)

The trial is fast approaching only 5 more months and it will be here. Many thanks to Nancy Giltner and Ann Hills for working with the AKC to get our information in on time and our judges lined up. The Agility, Obedience and Rally class and judge information has been posted on the AKC website.

Our judges for Agility are: Terry D Culley and Terry Le Clair. Entries open on October 5<sup>th</sup> and can be entered online through the AKC website. We will be having a 3 day agility trial. On Friday we will offer Excellent/ Master level only, Jumpers, Standard, Premier (STD and JWW), and T2B. Saturday and Sunday, all levels. Saturday will be Jumpers, Standard, Premier (STD and JWW), T2B and FAST. Sunday will be Jumpers, Standard, Premier (STD and JWW), and T2B.

We will be one of the first clubs to offer the Premier STD and JWW classes. These classes were approved to be offered as titling classes on October 1, 2015. **These classes are separate** from the STD and JWW classes that are part of the MACH/PACH requirements. (See information on pages 16-18 in this Newsette)

Obedience Judges are Mr. Dorin J Ladd, Mr. Jams D. Thomson and Mrs. Dee Dee Anderson. In Obedience we will be offering the Preferred Classes, with a Trophy approved by our board for **High Preferred Dog in Trial and a Trophy for High Preferred Combined** (Pref. Open and Pref. Utility) in Trial. Our Event Secretary will once again be Sharon Licciardi.

Our Rally judge for both days will be Vita Allison.

We will be having our Obedience and Rally match on Friday Dec 4. If you are interested in volunteering to help please contact Shiro Torquato. We will need help with ring stewarding to keep the match moving.

The Raffle Committee (Allison Pobirs, Cindi Malchose, and Jan Racey) are accepting Raffle donations, so please get your items to them.

Requests for Trophy sponsorship will be going out early in August. Most of the sponsorships are \$25.00 for each class. You will be getting yet another email from me.

## **AKC announces New Premier Agility Class**

June 18, 2015

We are excited to announce the newest AKC Agility class – Premier - starting October 1, 2015. This class will provide an opportunity for agility competitors to demonstrate different handling skills than those required for the Master Level Classes in Standard & Jumpers With Weaves. The Premier class will focus on handling the sequence or sequences of the day.

Premier is an optional class. Clubs may, but are not required to offer Premier Standard and Premier Jumpers with Weaves on the same day. Exhibitors may enter Premier and Master Standard and/or Jumpers With Weaves on the same day.

A club may add Premier to an already approved trial as long as the premium has not been published for the trial. The Trial Chairperson will need to send an email to the Companion Operations department to have it added. July 1, 2015 there will be the new trial application that will include the Premier classes as an option both for online applications and paper submissions.

Both Standard and JWW Premier courses will be Master level courses incorporating a number of elements that challenge the dog and handler in ways that are not seen on traditional AKC courses. These elements include sequences like threadles, back-side jumps, pull-throughs, layering, challenging weave pole entries, and longer running passes. One bi-directional jump or tunnel will be allowed to encourage handling strategies. Obstacle spacing on Premier courses may exceed the limits of those on Master courses.

Premier courses will use the same obstacles as the corresponding Master course. At the judge's discretion a viaduct may be used in place of the panel jump, there may be 3 tunnel passes and there will be no table. A Premier course will have 19 to 21 obstacles, 3 side switches, 4 Premier Elements and 5 Challenges. Courses will be judged using AKC Master scoring and hand signals.

### AKC Regulations - NEW Chapter 11 Premier Class

Section 1. Purpose. These optional titling classes are designed to challenge dogs and handlers at an increased speed and skill level above those set for the Master level classes. Handlers/dogs will need to negotiate courses that require varied approach angles, spacing, and obstacle discriminations to be successful in these classes. These classes are offered as separate titling tracks and are not part of the MACH/PACH Championships.

Premier may be offered once per day as an additional class or classes. Clubs may, but are not required to offer Premier Standard and Premier Jumpers with Weaves on the same day.

### AKC Regulations - NEW Chapter 11 Premier Class (cont.)

Section 2. Eligibility. Dogs with an AX title are eligible to enter Premier Standard Regular. Dogs with an AX or AXP title are eligible to enter Premier Standard Preferred. Dogs with an AXJ title are eligible to enter Premier Jumpers with Weaves Regular. Dogs with an AXJ or AJP title are eligible to enter Premier Jumpers with Weaves Preferred. Dogs with Regular titles may crossover to the Premier Preferred level as noted above.

### Section 3. Performance Standards

Minimum allowable score required to qualify = 100.

The course must be completed before the dog reaches the Maximum Course Time (MCT).

Additional Non-Qualifying faults (beyond those listed in Chapter 5, Sections 5 and 6).

Any Course Fault

### Maximum Course Times (MCT) Premier

### Standard Regular:

- 55 seconds for the 20 and 26 inch Regular jump heights.
- 60 seconds for the 16 and 24 inch Regular jump heights. -
- 65 seconds for the 8 and 12 inch Regular jump heights.

### Preferred:

- 60 seconds for 16 inch Preferred jump height.
- 65 seconds for 12 and 20 inch Preferred jump heights.
- 70 seconds for 4 and 8 inch Preferred jump heights.

Note: For timing purposes all Premier Standard classes may have timer set for MCT of 70 seconds.

### Premier Jumpers With Weaves Regular:

- 40 seconds for 20 and 26 inch Regular jump heights.
- 45 seconds for the 16 and 24 inch Regular jump heights. -
- 48 seconds for the 8 and 12 inch Regular jump heights.

### Preferred:

- 45 seconds for 16 inch Preferred jump height.
- 50 seconds for 12 and 20 inch Preferred jump heights.
- 53 seconds for 4 and 8 inch Preferred jump heights.

Note: For timing purposes all Premier Jumpers With Weaves classes may have timer set for MCT of 53 seconds.

### AKC Regulations - NEW Chapter 11 Premier Class (cont.)

### Minimum Obstacle Requirements:

Quantity = 19-21

Obstacles required, allowed, and not allowed will be the same as the Master level courses as noted in Chapter 6, Section 5 for Standard; and Chapter 7, Section 5 for Jumpers With Weaves, except that both classes will have a maximum of three tunnel passes and Standard will not have a table.

In both classes the viaduct jumps, as described in Chapter 13, Section 9, can be substituted for the panel jump or a spread jump, as long as the viaduct jump can be set for all heights.

Section 4. Obstacle and Jump Positions. Shall generally follow the requirements set forth in Chapter 4, Section 4, with the following exceptions:

A Distance of 25 - 30 feet between two obstacles may be approved up to two times on a course.

Distances of greater than 30 feet between obstacles may be approved to allow for turns between obstacles as necessary.

There may be one bi-directional tunnel or bar/single bar jump on the course.

Section 5. Approach Angles. Shall generally follow what is stated in Chapter 4, Section 5, except as detailed in the AKC Agility Judges Guidelines for the Premier Class.

Section 6. Titles. To earn the Premier Agility Dog (PAD), Premier Agility Dog Preferred (PADP), Premier Jumpers Dog (PJD) or Premier Jumpers Dog Preferred (PJDP) titles, a dog must earn 25 qualifying scores with five qualifying scores earned for placing in the top 25% of the dogs that competed in their jump height.

Dogs that are absent or withdrawn will not count toward the number of dogs competing in the jump height. The 25% calculation will be rounded to determine the number of 25% placements in each jump height. In the case of a tie both dogs will receive the top 25% placement. If a class has two or three dogs competing, the 1<sup>st</sup> place dog will be awarded a top 25% placement qualifying score. If only one dog competes in the jump height, there will be no top 25% placement earned in that jump height.

Lifetime Achievement titles (bronze, silver, gold and century) will be awarded for each additional 25 qualifying scores earned in the Premier class.
